Notice is hereby given that in accordance with Section 66.1003(4) of the Wisconsin Statutes, the Town of Saratoga, Wood County, Wisconsin will hold a Public Hearing regarding the discontinuance of a portion of certain public way located in the Town of Saratoga, Wood County, Wisconsin, more particularly described below, at a meeting of the Town Board, which is to be held at the Town of Saratoga Town Hall – 1120 State Hwy 73 S., Wisconsin Rapids, WI. 54494- on the **15th day of November, 2023 at 6:00PM**. The certain road portions are described as follows, to-wit:

An undeveloped portion of Mill Avenue, located in the Northwest Quarter of the Northwest Quarter (NW1/4, NW1/4) of Section 16, Town 21 North, Range 6 East, more particularly described as follows:

Commencing at the NW Cor. of Section 16, Township 21 North, Range 6 East, said point being the POINT OF BEGINNING. Thence S $88^{\circ}10'16''$ E a distance of 486.65' along the North line of Section 16 (to point PRW5 as shown on Transportation Project Plat (TPP) 6320-08-22-4.03 recorded in Volume 13 of Plats, Page 73, as Document Number 2011R01908 Wood County Register of Deeds). Thence S $69^{\circ}10'17''$ W a distance 85.66' (to point PRW69 on said TPP). Thence N $88^{\circ}10'16''$ W a distance of 7.37' to the Point of Curvature. Thence Southwesterly a distance of 119.88' along the arc of a curve concave to the Southeast, having a radius of 680' (the chord bears S $53^{\circ}26'55''$ W 119.73') Central Angle = $-10^{\circ}06'04''$. Thence N $80^{\circ}00'03''$ W a distance of 130.27' to the Point of Curvature. Thence Northwesterly a distance of 119.70', along the arc of a curve concave to the Southwest having a radius of 1145.00', (the chord bears N $60^{\circ}21'35''$ W 119.64') Central Angle = $-5^{\circ}59'23''$. Thence N $88^{\circ}10'16''$ W a distance of 4.26' (to point PRW 70 on said TPP). Thence N $62^{\circ}03'51''$ W a distance of 74.99; to the NW Cor. Of said Section 16, being the POINT OF BEGINNING.

Copies of a map of the above-described section, are available for viewing at the Town Hall, 1120 State Hwy 73 S., Wisconsin Rapids, WI. 54494. All interested parties are invited to attend said hearing and be heard. After the public hearing, the Town Board will consider a proposed Resolution for discontinuance of the portion of road as described above.
